

51st Annual Winter Art Fair

Arts in Action invites you to participate in the Winter Art Fair to be held at the Fremont Center (on the Fremont County Fairgrounds in Riverton, WY) **Friday and Saturday, November 22 and 23, 2024**. The hours will be Friday from 5-8 p.m. and Saturday from 9 a.m. to 3 p.m.

The following rules have been adopted to keep the Winter Art Fair running smoothly:

1. All work must be original and made by the artist/craftsperson (no kits or commercially produced products). We have had issues with vendors ignoring this very important aspect of the fair and ask for full cooperation from all vendors.
2. A **\$65** fee is charged for each booth space. Each booth is approximately 10' x 10'. Please make checks payable to Arts in Action. Payment may also be made by money order, cashier's check, or cash. There is a limit of two booths per person or group.
3. All art or craft work *must be for sale* with a visible price or specified as an example for future sales orders.
4. We provide one table and two chairs per booth, with a limited number of extra tables available upon request.
5. Let Arts in Action know if you must have electricity so that your booth is placed near an outlet. Wall spaces are generally reserved for those requiring electricity. Most outlets are shared between two booths. Please plan on bringing your own extension cords.
6. Admission fee of \$1.00 will be charged for mem. Proceeds benefit Arts in Action, a non-profit organization that strives to promote the Arts in Riverton and Fremont County. Proceeds are used to bring in art exhibits and performances to Riverton that would otherwise be too costly.
7. Arts in Action and the Fremont County Fair will not be responsible in any way for damage or loss of any art or craft project, any other kind of property loss, physical damage, or personal injury.

There will be a member of Arts in Action at the Fremont Center Friday, November 22nd beginning at 12:00 p.m., to assist you. *Doors will not be open before that time.* Please unload and move your vehicle ASAP and park in designated areas only. Please do not leave your vehicle in front of the building.
